Agenda Item 1 – Public Comment

Agenda Item 2 – Mission Moment

Ms. Dusseault introduced the Board to Mses. Kennedy and Nguyen. The Board engaged in a brief discussion with Ms. Kennedy on her background in education and work that she is doing in GDPSW schools. Ms. Nguyen informed the Board about her interest and work at GDPSW in development.

Agenda Item 3 - Board Business

Co-Chair Hailey moved to elect Messrs. Thiel and Wang to the Board for respective terms through December 31, 2018. Ms. de Barros seconded the vote, which passed unanimously by the Board members present at the time of the vote. (All Board members were present for the vote.)

Ms. Dusseault discussed the Washington Commission Annual Reports for GDPSW's Destiny Middle School and Excel Public Charter School, which include school goals, student demographic information, and academic data.

Ms. Herrera discussed the proposed GDPSW contingency budget for the 2017-2018 fiscal year (the "Contingency Budget"). Co-Chair Hailey moved to approve a resolution to adopt the Contingency Budget. Secretary Cunningham seconded the motion, which passed unanimously by the Board members present at the time of the vote. (All Board members were present for the vote.)

Ms. Dusseault discussed GDPSW's five-year budget projections and highlighted the funding needed to be financially sustainable.

Agenda Item 4 – Consent Agenda

Co-Chair Hailey moved to approve the Consent Agenda, which contained: (1) Minutes from the Board's August 29, 2017 special meeting; (2) Minutes from the Board's September 14, 2017 regular meeting; and (3) a resolution to approve a Washington State deferred compensation plan pursuant to Internal Revenue Code Section 457(b). Co-Chair Kondracke seconded the motion, which passed by the Board members present at the time of the vote. Secretary Cunningham abstained from this vote. (All Board members were present for this vote.)

Agenda Item 5 – Executive Director Update and Discussion

Ms. Dusseault updated and discussed with the Board regarding the following:

- GDPSW's student academic performance;
- GDPSW's human capital goals for the 2017-2018 and 2018-2019 school years, as well as GDPSW's staff demographic data;
- GDPSW's enrollment;
- progress at each of GDPSW's schools; and
- the "End of Year 2017 Campaign to raise funds for GDPSW between late November 2017 and early January 2018.

With no further GDPSW business to discuss or transact, Co-Chair Hailey adjourned the meeting at approximately at 6:20 p.m.
